JUNE 15, 2026 MINUTES

BOARD OF DIRECTORS MEETING

CALL TO ORDER AND PERSONS ATTENDING. The regular monthly meeting of the Board of Directors was called to order at 6:0 p.m., at Millington Fire Station Number 1. Directors Jay Hanna and Sharron Wells were present at the fire station. Directors Kelley Andrews and Jordan Slape attended via Zoom.

PUBLIC COMMENT. No public comment.

CONFLICT OF INTEREST. None declared.

MINUTES. Sharron moved to approve the minutes from the May 18th, 2026 Budget Committee mtg. Kelley seconded the motion. The motion passed unanimously.

Sharron moved to approve the minutes from the May 18th, 2026 regular board meeting. Kelley seconded the motion. The motion passed unanimously.

BILLS PAID. Kelley made a motion to approve the payment of checks 8059-8061 as described on the ledger. Sharron seconded the motion. The motion passed unanimously.

Unfinished Business:

CCF&R Contribution. In May, the district received \$2,121.37 in tax distributions. Jordan moved to write check 8062 to CCF&R in the amount of \$1,803.16 in keeping with the 85% IGA contribution. Kelley seconded the motion which passed unanimously.

New Business

Adopt Proposed Budget. Jordan moved to adopt the budget resolution for fiscal year 2026-2027 as presented by the budget committee. Jay seconded the motion. The motion passed unanimously.

CCFR Chief Rob Aton, Sumner board members Lisa Bettiga, Gidgette Hill, Brett Mosieur and Dr. James Woods joined the meeting at 6:10 p.m.

Accuity Contracts. Accuity, LLC, Certified Public Accountants, sent a contract to the department sometime in January but it only made its way to the board at the end of May. There was an Agreed-Upon Procedures contract for the district to engage Accuity to complete AUPs for fiscal years ending June 30, 2026, 2027, and 2028 for the sum of \$8,500.00 annually. There was also a Compilation Contract encompassing the same fiscal years for the sum of \$4,000.00 annually. Sharron moved to sign both contracts, engaging Accuity. Jay seconded the motion. The motion passed unanimously.

Sumner Fire board member Kris Smith arrived at 6:17 p.m.

CCF&R Update. From May 18th, 2026 to June 15th, CCF&R responded to 24 medical calls, 1 motor vehicle accident, 3 fires (1 wildland, 2 structure), for a total of 28 calls. There was no

change in volunteers.

There are no out-of-area trainings this month. We are still waiting on the new pump motor for Brush 2. Chief Aton will ask the CCF&R board to purchase hydrant packs and Holmotro Nippers. We received a new-to-us Ford Expedition from the Sheriff's Office and are working to get it into service. It will be used as a technical rescue vehicle. The FEMA Assistance to Firefighters grant application was submitted requesting tenders for both Millington and Sumner. The Summer Staffing Grant started June 1st and we have 2 firefighters on duty during the day. The fire level was raised today.

Jay moved to adjourn the meeting at 6:25 p.m. Kelley seconded the motion, which passed unanimously.

The financial statements are prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The accompanying cash basis budget of the Millington Rural Fire Protection District for the year ended June 30, 2026 has not been compiled or examined by me and, accordingly, I do not express an opinion on any other form of assurance on it. The forecasted or projected results may not be achieved and I assume no responsibility to update the report for events and circumstances occurring after the date of the report.

Management has elected to omit substantially all the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the District's assets, liabilities, equity, revenues, and expenses. Accordingly, the financial statements are not designed for those who are not informed about such matters.

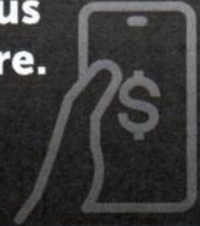

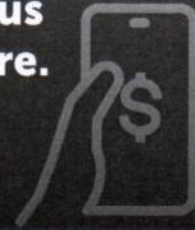
